

RESOLUTION

WHEREAS, the owners of a majority of the number of acres in the land hereinafter described in this Resolution, which land is contiguous to the City of Albuquerque, New Mexico, have presented a petition properly signed by them, accompanied by a survey and a plat of said contiguous territory, requesting and petitioning the City Commission of Albuquerque to pass and adopt a Resolution annexing the said land to the said City, and

WHEREAS, the said petition complies in all respects with the provisions of Section 14-606, New Mexico Statutes, 1941 Annotated.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF ALBUQUERQUE, NEW MEXICO:

1. That the said City Commission hereby indicates its consent to the annexation to the said City of that certain land contiguous to the said City and more particularly described as follows, to-wit:

A parcel of land situate in Section 1, 2, 3, part of the E. $\frac{1}{2}$ of Section 4, part of the E. $\frac{1}{2}$ of Section 9, all of Section 10 and part of N. $\frac{1}{2}$ of Section 15, T. 10 N., R. 3 E., also part of the S. $\frac{1}{2}$ of the following sections: 33, 34, 35 and 36, T. 11 N., R. 3 E., N.M.P.M.

All the above mentioned land is more particularly described as follows:

Beginning at the point of intersection of the East Boundary Town of Albuquerque Grant Line with the South Boundary Elena Gallegos Grant Line;

Thence East along the said South Boundary Elena Gallegos Grant Line to the East line of said Section 36, T. 11 N., R. 3 E.;

Thence South along the said East line of Section 36 and the East line of said Section 1, which is also a City Limit Line, to the S. E. corner of said Section 1, T. 10 N., R. 3 E.;

Thence West along the South line of said Sections 1 and 2 to the S. W. Corner of Section 2, which is also the N. E. Corner of said Section 10, T. 10 N., R. 3 E.;

Thence South along the East line of Section 10 and the East line of said Section 15, to a point on the present City Limit Line at Wilson Avenue;

Thence in a westerly direction along the present City Limit Line to Richmond Avenue;

Thence North along the present City Limit Line and the center line of Richmond Avenue to Hannett Avenue;

Thence West along the present City Limit Line and the center line of Hannett Avenue to Girard Avenue;

Thence North along the present City Limit Line and the center line of Girard Avenue to Morrow Avenue and the South line of Section 10;

Thence West along the present City Limit Line and the South line of said Sections 10 and 9 to a point on the East Boundary Town of Albuquerque Grant Line;

Thence North along the East Boundary Town of Albuquerque Grant Line to the point or place of beginning and containing 3320 acres more or less.

and the City Clerk of the City of Albuquerque is hereby directed to file a copy of this Resolution, together with a copy of the plat of the foregoing described real estate in the office of the County Clerk of Bernalillo County, New Mexico

2. That from and after the filing of said copy and map with the said County Clerk the foregoing described real property shall be included in and made a part of the said municipality for all purposes.
